## **INTRODUCTION**

### ***Why Is This Plan Important?***

The Bryce Jordan Center, a major entertainment venue located at The Pennsylvania State University, is the home to the weekend-long Penn State IFC/Panhellenic Dance Marathon. It is crucial to be prepared for any emergency that could damage or threaten the BJC or THON.

Since THON's move to the BJC in 2007, both staff and volunteers have excelled in providing our target audiences with exceptional service and safety earning both organizations a good reputation. Because of the high standards upheld by both the BJC and THON, we need to make sure that we are prepared to handle any situation that could occur in the best way possible to ensure the optimal safety and security for those in attendance during THON weekend.

### ***What Could Happen If The Plan Is Not Followed?***

If this crisis communications plan is not followed in the event of an emergency, the BJC's and THON's reputation could be destroyed, which could result in the closure of the BJC and the end of the largest student-run philanthropy in the world. Responsibility and security are of extreme importance to all during THON weekend at the BJC. THON attendees trust that BJC staff and THON volunteers will help to keep them safe and secure during THON weekend.

### ***Has A Crisis Happened At A Similar Event?***

Similar crisis situations have occurred when envelopes with anthrax spores were mailed to head media offices and U.S. Senators in 2001. We can learn from tragic events such as this to make better decisions in our crisis communication plan. Although the BJC and THON have been extremely fortunate to have not experienced any event on the scale of a crisis, we must still be prepared for any type of emergency and we must always be ready.

## **PURPOSE AND OBJECTIVES**

### ***Purpose***

In the event of an anthrax attack at the Bryce Jordan Center during THON weekend or any other potential crisis, it is necessary to take immediate action in informing the public of the event that has occurred and the steps that are being taken to handle the situation. By acting in an open and honest manner when communicating with the media and other outlets, we will be able to eliminate the possibility of miscommunication. Our honesty and efficiency will allow for the crisis situation occurring at the Bryce Jordan Center to be handled in an appropriate manner and prevent any similar future crisis from happening.

### ***Objectives***

We will make every effort to:

- Evaluate the anthrax attack to our best ability and take preventative action to protect the THON attendees at the Bryce Jordan Center.
- Initiate the phone tree in the event of a crisis situation, informing all staff and THON volunteers on hand of the situation and evacuating all THON attendees from the building.
- Initiate the crisis communication plan immediately after a crisis outbreak in the building.
- Notify emergency personnel, including the FBI and law enforcement.
- Inform all health care personnel needed to assist in the situation.
- Inform the media during a press conference once the crisis has become controlled.
- Inform the Penn State, State College and THON communities of the crisis.
- Keep the media and publics regularly informed on updated information through regular media reports and updates to the Bryce Jordan Center's and THON's dark site.
- Maintain honesty with the media about known information.
- Work with FBI, law enforcement and Old Main officials to understand the source of the problem and investigation details.
- Develop solutions to prevent future occurrences.
- Evaluate decisions and the current crisis communication plan.
- Taken preventative action by implementing any necessary changes to the crisis communication plan as well as Bryce Jordan Center and THON security.

## **BEST OPTION PROCESS**

**Problem:** Anthrax has been released inside of the Bryce Jordan Center during THON weekend through the vent system that circulates air around the event floor of the arena. The substance has been inhaled by several of the 15,000 in attendance.

**Urgency:** Inhalation of anthrax is the deadliest form of exposure. When spores of anthrax are inhaled, they migrate to lymph glands in the chest where they proliferate, spread, and produce toxins that often cause death.

Symptoms appear within one to seven days of contracting the agent. Treating the infectious disease as soon as possible is important. Death usually follows two days following the appearance of symptoms.

**Outcome Desired:** The goal is to safely evacuate all participants out of the Bryce Jordan Center. Upon evacuation, the next goal is to inform all attendants throughout the entire THON weekend and get them all treated as soon as possible.

### **Solution Options:**

1. Quarantine the Bryce Jordan Center to keep the anthrax from spreading.
2. Distribute hazardous bodysuits and facemasks to participants to prevent the inhalation of the anthrax. Begin the evacuation of the Bryce Jordan Center.
3. Immediately evacuate the Bryce Jordan Center. Set up designated areas in the Intramural Building where people that were inside the Bryce Jordan Center can be tested to see if they have inhaled anthrax. Those that test positive will immediately be sent to Mount Nittany Medical Center and surrounding hospitals in the area for medical attention.

### **Best Option:**

The best option for anthrax inhalation at THON scenario would be solution option #3, to evacuate those that were inside of the Bryce Jordan Center at the time of the attack to the Intramural Building to be tested to see if they are positive for anthrax inhalation. The next best option is solution option #2, to distribute hazardous bodysuits and facemasks to those inside the Bryce Jordan Center and then begin the evacuation.

### **Reasons:**

Solution option #3 is the best option during this situation, as it wastes no time in evacuating the Bryce Jordan Center. THON attendees that were inside the BJC at the time of the attack will receive immediate attention to see if they test positive for anthrax. This is important to identify

as soon as possible because if it is not treated in a timely manner, anthrax can be fatal. In addition, several attendees at THON are children that are currently battling cancer with severely weak immune systems. If these children have inhaled the substance, they need immediate medical attention to increase their chance of survival.

## **LAYOUT**

- The Bryce Jordan Center has four main gates available to the public on the concourse level
- The concourse separates the Concourse Level from the Event and Lower Event Levels
- The Concourse Level is the top deck of the Jordan Center. The sections begin with Row A and extend up to Row S on the ends and Row P on the sides of the arena. The rows contain 16 seats per row and are numbered 1-16.
- The Event Level is the middle part of the arena. The sections begin with Row A at the bottom of the section and extend up to Row P at the top of the section, where the main entrances are. The rows contain 16 seats per row, except for the corners, and are numbered 1 - 16.

- The Lower Event Level is located below the Event Level and contains Row KK, which is on the Floor Level and extends up to Row AA, which touches the base (Row A) of the Event Level. The rows contain 16 seats, except for a few sections, and are numbered 1 - 16.
- The Floor Level Varies from show to show.
- There access to the Event Floor from the East and West Truck Ways.

## **SECURITY**

- Every student must present a PSU student I.D.
- All small bags and purses are screened.
- No large bags, backpacks and duffels are allowed inside the doors.
- Outside food and beverages will not be permitted inside the BJC.
- Coats may be worn inside but must be temporarily removed during entrance past security.
- All entrances have security.

- Located at the corner of University Drive and Curtain Road.
- On the East side of the Penn State University Park Campus

## HOLDING STATEMENT



### **THON Weekend Anthrax Attack**

The Pennsylvania State University confirms that it has received information about an anthrax attack during THON weekend. At this point in time, we have received news that the attack began early on during the event, and came to a peak on Saturday, February 21st at approximately 6 a.m. We have the students, volunteers, State College residents, and every member of the Penn State Community's safety as well as best interests at heart. The proper safety plans are in action. We have contacted the Center of Disease Control and are working on setting up triage units as we speak.

More than 7,000 participants may be involved in this crisis. If you think you may have been exposed to anthrax, please call the CDC hotline **1 (800) 232-4636**.

Our hearts go out to everyone in harms way, and we hope for their safe recovery. We will keep you updated as we get more information.

## **INCIDENT IDENTIFICATION**

**Type of incident:** A bioterrorist attack has been unleashed on the Bryce Jordan Center during THON at The Pennsylvania State University. The rare biological agent anthrax was used in the terrorist attack. The spore like bacteria is not immediately harmful, but can cause death if not treated as soon as possible.

**Details of incident:** On February 21, 2015 a massive outbreak of anthrax has been unleashed in the Bryce Jordan Center during Penn State's THON weekend. The anthrax bacteria have been inhaled and infected more than 7,000 participants during the early hours of the event.

**Actions taken:** Contact everyone on phone tree, both internal and external. Alert victims in the Bryce Jordan Center that a hazardous substance has been released and they must be evacuated to the nearby Intramural Sports Building for medical testing. Send those that test positive for anthrax inhalation to neighboring hospitals such as Mount Nittany Medical Center for medical attention. The Bryce Jordan Center needs to be quarantined to prevent the disease from spreading.

**Support required:** Local authorities will be needed to help prevent chaos from occurring. Medical areas set up in the Intramural Sports Building will help THON attendees that were inside the Bryce Jordan Center at the time of attack establish whether they have inhaled the substance or not. Homeland Security/CDC may want to set up quarantine to keep the disease from spreading.

## **POTENTIAL QUESTIONS**

### **Q#1: Do you believe this was a terrorist attack?**

A#1: We have reason to believe this is an act of terrorism. Anthrax is an incredibly severe substance and its spreading is taken very seriously.

### **Q#2: Were there any previous threats?**

A#2: There were no previous threats to THON or any other events that were recently held at the Bryce Jordan Center.

### **Q#3: Has a suspect been identified?**

A#3: As of right now there are no suspects in the case. We are currently reviewing video surveillance from inside of the Bryce Jordan Center to identify any possible suspect or suspects.

### **Q#4: Are there multiple suspects?**

A#4: There is potential for multiple people to have been involved in plotting the accident. As of now there are no suspects and we are reviewing video surveillance from the Bryce Jordan Center.

### **Q#5: Were there any fatalities?**

A#5: The symptoms of anthrax takes several days to take effects, currently medical reports show that there have been no fatalities as of yet.

### **Q#6: Where were those who were infected taken?**

A#6: Those that tested positive for anthrax inhalation were taken to hospitals in the area including Mount Nittany Medical, UMPC Altoona and Penn State Hershey Medical.

**Q#7: What authorities are involved?**

A#7: We are currently working with State College Police as well as the FBI and Department of Homeland Security to find the suspect or suspects.

**Q#8: What security measures are currently being taken at the BJC?**

A#8: We have closed down all buildings and activities on campus and have a police line set up around the BJC. We are working with the FBI and police to find out more information on the attack.

**Q#9: What type of chemical or weapon was used?**

A#9: We have determined that anthrax was released inside of the Bryce Jordan Center.

**Q#10: At approximately what time did the incident occur?**

A#10: The incident occurred on Saturday 21, 2015 at approximately 6:00 a.m. inside of the Bryce Jordan Center.

**Q#11: How many people were inside of the BJC at the time of the attack?**

A#11: We estimate that there were a total of 7,000 THON participants during the time of the attack.

**Q#12: What evacuation procedure was followed after the attack?**

A#12: Our evacuation plan was to safely get participants outside of the BJC and over to the Intramural building across the street where they will be tested for a possible anthrax inhalation.

**Q#13: What location were attendees evacuated to?**

A#13: Attendees were evacuated to the Intramural Sports Building located on Curtin Road to be tested for possible anthrax inhalation.

**Q#14: Where any Four Diamond Families impacted?**

A#14: At this time, we are not publically announcing the names of those who have been affected by the anthrax attack. We are currently working on contacting family members of those in need of medical attention.

**Q#15: Was the attack directed towards any person or group in specific?**

A#15: As of right now, we do not have enough information to suggest if this attack was directed towards any person or group in specific. We are working to establish a suspect or suspects in the case that will help to answer this question.

**Q#16: Has your staff been properly trained to prepare for such an incident?**

A#16: the staff has been prepared for emergency situations in which evacuation is necessary. We have simulation drills two times a year to help prepare for situations like this.

**Q#17: What steps will the BJC/THON being taking to prevent this from happening again?**

A#17: Right now the focus is on handling the current situation.

**Q#18: Why are all attendees being kept inside the BJC?**

A#18: All attendees were evacuated from the Bryce Jordan Center and taken to the Intramural Building located on Penn State's campus. Attendees are being tested for possible inhalation of anthrax at the Intramural building and those testing positive are being taken to nearby hospitals for medical attention.

**Q#19: Are there currently any other chemical threats around the Penn State campus?**

A#19: At this time we have no reason to believe that there is any other type of chemical threat on the Penn State campus.

**Q#20: Is there any security footage that hints at who could have carried out the attack?**

A#20: We are currently viewing the video surveillance footage from cameras both in and outside of the Bryce Jordan Center. When we have more information on the matter the media will be contacted.

**Q#21: Is the attacker still believed to be in the BJC?**

A#21: As the Bryce Jordan Center has since been evacuated the attacker is not in the building.

**Q#22: How are you dealing with the concerns of family members and students?**

A#22: We have been answering all questions and concerns via telephone, email, and through our dark site.

**Q#23: What security measure had been taking place at the BJC prior to the attack?**

A#23: State College Police as well as University Police have been directing traffic and patrolling both inside and outside areas of the BJC.

**Q#24: How are you communicating with families of those affected?**

A#24: We are currently gathering emergency contact information from all of those that were in attendance at THON during the time of the attack. We will be using this information to make phone calls to families as well as send text message and e-mail updates as the situation evolves.

**Q#25: How do you think this incident will affect attendance at future events?**

A#25: The future of THON at Penn State will be left in the hands of the president and board members of the university. If THON were to continue at Penn State, security measures will have to be amped up to ensure a situation like this never happens again.

**ANTHRAX INVADES PENN STATE'S THON WEEKEND**

UNIVERSITY PARK, Pa., Feb. 21- At approximately 6:00 a.m. this morning, an anthrax attack has been released through the air vents at the Bryce Jordan Center during THON, a dance marathon benefiting kids with cancer. The local and federal authorities are currently working on the investigation.



It is estimated that 7,000 people were in attendance during the attack, most of which have been exposed to the biological agent. Anthrax is a life-threatening disease that can be transmitted to humans by contact through skin or inhalation. It does not spread from person to person. Exposure to anthrax takes one to seven days to show symptoms in its infected victims. If not properly treated, an outcome can be possible death.

BJC ANTHRAX SCARE  
2-2-2-2-2

The Bryce Jordan Center has been evacuated and pedestrians have been moved to the designated safety zone at the Intramural building, located across from the BJC. The University is currently working with Penn State Hershey Medical Center, UMPC Altoona, and Mt. Nittany Medical Hospital to test and treat participants at the Intramural building. There have been no reports of any casualties so far, but 31 participants have been rushed to the hospital and placed into critical care. A perimeter has been set up around the Bryce Jordan Center to prevent further harm to the media and local community.

At this time, we extend our deepest regrets and condolences to those affected by this tragic event and to their families. The Bryce Jordan Center and authorities are doing everything they can to investigate the situation and take preventative actions to keep this from occurring again.
